RELEASE, WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT

I hereby assume the risk of all losses, harms, injuries, or damages, and further release and waive any and all liability of South Tampa Paintball, LLC, and all of their agents, employees, officers, volunteers, other participants and players, sponsors, advertisers, landlords, and trusts, owners, and trustees (hereinafter "STP") from any and all claims that may arise from my participation and/or spectating in and around STP.

I understand and accept all of the inherent risks, known and unknown, and all hazards relating to watching, participating, and volunteering in activities of STP including: risk of significant injury, including disability, loss of sight, or hearing, and even death. I assume the risk for my own acts negligence, and/or negligence of others, intentional acts of others, faulty equipment, attack by, or encounter with plants, insects, reptiles, and/or animals. I understand that the description of these risks is not complete and that unknown or unanticipated risks are also assumed and waived by myself, my estate, my heirs, survivors, executors, and assigns. I agree to hold STP and others harmless, and to indemnify, save, and hold harmless from any loss, liability damage, or cost which STP may incur as a result of such claim.

I represent that I fully understand the nature of the activities at STP, and that I am qualified, in good health, and in proper physical condition to participate, spectate and/or volunteer in all such activities, and that if I believe that something is unsafe, I will immediately discontinue participating in the activity.

This release, waiver of liability, assumption of risk, and indemnity agreement shall be effective for all time, past and future. This release also releases any and all claims arising out of privacy, commercial use of likeness for photographs and/or videos used by STP for any purpose.

I am fully responsible for loss, damage, and/or repair of rental equipment and agree to pay for any such loss, damage, or repair. I also understand that outside paint is not permitted in STP equipment and using any outside paint may result in removal and disposal at the discretion of management.

I have read this release of liability, assumption of all risks, and indemnity agreement, and I fully understand its terms and understand that I have given up legal rights by signing it, and I sign it freely, voluntarily, knowingly and without any inducement and assurance of any nature and this is intended to be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this agreement is held to be invalid, the balance of this agreement, notwithstanding any invalid portion, shall continue in full force and effect.
